Attendance. Coach Kolleen will address her expectations there will be 1 excused and 1 unexcused absence. Cheer Leaders will be pulled and placed as an alternative. She requests all correspondence in email and not last minute. A no show with no correspondence will be automatic probation. She will go over more details on this.

Alternatives- Coach Kolleen will discuss how she does this.
